

This was a great opportunity for individualized assistance with JGSCV member's own family history. Thank you to the LA Family History Library missionaries who gave up their Sunday to open for us and to provide assistance. A special thank you to JGSCV senior members who provided the personalized assistance: Hal Bookbinder, Debra Kay Blatt, Warren Blatt, Andrea Massion, Issie Perel and Marion Werle. JGSCV also had six new members join! This annual event is one of several members-only benefits. While we ended in 2014 with 169 members we are at 128 for 2015. members-only feature started in January only for 2015 dues paid members: discounts for Findmypast Legacy Webinars (50% off), and 50% off a subscription to MyHeritage. The MyHeritage offer had a very short window of opportunity— 10 days in January and there will be another 10-day opportunity later in the year. The other organizations' offers are not as time-sensitive. Findmypast has increased their discount and information will be sent to 2015 members.

JGSCV treasurer Karen Lewy will be presenting the 2015 budget to the JGSCV Board at our March board meeting. It costs JGSCV to do all that we do about \$5,000 a year. Membership dues do not cover our expenses. Therefore, we rely on outside sources to supplement our budget. The two largest outside funding sources are Amazon.com and Ralphs Community Program. Collectively, Amazon and Ralphs are 25 percent of our revenues. When you are shopping on Amazon.com please start at the JGSCV website and enter Amazon through our portal by clicking on the Amazon logo at the bottom of our home page. At no additional cost to you, JGSCV receives a marketing fee when you follow those simple steps. See "JGSCV Updates" on page 5 for more details. We have been averaging fees of about 6.5% of purchases and we need that revenue to maintain our level of services.

2014 was the 100th anniversary of the beginning of World War I and 2015 is the 70th anniversary of the end of World War II. In early December, I sent out an email to members asking about any genealogical research you have done on your family who might have either fought in either war or were involved in the wars because of their locations. This includes the holocaust. The stories can be about you too if you served or are a survivor. We received and published several submissions from Werner Frank, Sara Applebaum – and on page 9 is this month's by Barbara Algaze. ### Litvak SIG Adds Records

Eden Joachim, President of the Litvak SIG hosted by Jewishgen.org has announced the addition of 47,469 new records to the All Lithuania Database (ALD). Many districts are represented and the new records cover several categories: Births, Deaths, Marriages, Divorces and Tax Lists. <http://www.litvaksig.org/all-lithuania-database-ald>

Please search even if you don't think you'll find anything. Some types of records fall into categories which don't fully explain the type of record due to the template they use. For example, the new records include Real Estate Owners and different types of Savings Bank records.

### Poland: Change in Civil Law Records Made Final

A new Polish law, to be enacted on March 1, 2015, reduces the embargo periods to 80 years for marriage and death records from the previous existing law of 100 years! This is a substantial and very welcome change. It does retain birth records embargo at the previously existing 100 years.

### And in England...

A bill before the (UK) House of Lords has amended to allow for publication on birth, marriage and death certificates in England and Wales, to be issued in a manner other than certified copies. This is a great example of how genealogists can influence actions. If passed, there would be upgrades in the technology of the gov't that would take a while. ## The Topic: Ancient Texts Lead to Genealogical Discoveries - The Lives Our Ancestors Led

The Jewish Theological Seminary in New York is often off the radar screen for many genealogists but the library is home to almost half a million volumes including manuscripts, rare books and archives. The archives are a treasure yet to be explored by so many of us and yet it is a rich repository of records of Jewish communities, institutions and prominent individuals in the US and Europe. We will take a digital trip and explore some of the treasures that can be found at JTS. Included in these archives are transcriptions of notes, memos and correspondence between the State Department and offices in Vienna, St. Petersburg, Warsaw and Bucharest from 1863-1906 that concern the legal position and persecution of Jews; and correspondence and notes about the Jewish community in France from 1700's until after WWII. We will also explore a variety of ketubot and mohel books and talk about the way all of these materials help us in our research.

**Speaker:** Dr. Janette Silverman is the JewishGen Ukraine SIG Coordinator. She was the president of the Phoenix Jewish Genealogy Society for 5 years, and is active on the IAJGS Membership Development Committee. Since 2007 she has served as a Moderator for the JewishGen Discussion Group. Her doctoral dissertation, "In Living Memory" is about Jewish genealogical research. Janette has been researching family history for almost 30 years. Janette is the Outreach Director for the William Davidson Graduate School of Jewish Education of The Jewish Theological Seminary in New York.

# Highlights from: JGSCV's Annual Assisted Research Afternoon

Each year JGSCV is privileged to hold an exclusive assisted research afternoon at the Los Angeles Family History Library. The missionaries at the LA Family History Library give up their Sunday to open the library for us and help with providing direction to JGSCV members. In addition to the missionaries, senior JGSCV members provide personal hands-on assistance to JGSCV members to help them with their family history research. We had 35 avid genealogists make the long drive to take advantage of this special program available only to JGSCV members.



Barbara Algaze, a JGSCV member, and librarian of our sister society, JGS Los Angeles, presented an informative talk on “Exploring the Family Search Website”. Her handout is posted to the JGSCV website, [www.jgscv.org](http://www.jgscv.org) under “meetings/prior” with the February 15, 2015 date. Barbara prepares a different lecture each year and this one focused solely on the FamilySearch website, [www.familysearch.org](http://www.familysearch.org).

The presentation reviewed search functions and historical records. Barbara demonstrated how to complete the search

questions, the differences between exact (clicking on the square box next to the name) and using the default phonetic spelling. She also demonstrated how to search relationships—which is very useful, especially when searching a common name such as Harry Schwartz. Adding location, such as Brooklyn, is helpful in narrowing the search. Location is where the person was at a particular time, Location is where the person was at a particular time, it is different than the birthplace.

Barbara also explained the Soundex Code. It was developed by the US Government to help them find names on records. The first letter of the name and only the next three consonants, not vowels, are used to combine into one code the variations of spelling of a name. Barbara’s surname A-L-G-A-Z-E would be A lgz and the l, g, z would each have a numerical designation and would be A 422. (To learn more about Soundex see <http://en.wikipedia.org/wiki/Soundex>)



## Search Historical Records

Searching on FamilySearch is free. You need not register on the FamilySearch website unless you want to upload your trees or order microfilms to be borrowed.

Another attribute of the FamilySearch website are the “collections” module. This will help you organize your searches – for example you can place births, marriages and Social Security Death Index numbers all into different collections. One can also refine their search. Other attributes are copy and print.

If you are using your own computer at home vs. the computer in the Family History Library, you can download the copy to your computer. You can view the document and print it as well.

One of the websites that will be of great assistance in researching graves is <http://findagrave.com/> which has 120 million graves worldwide, listed on their site. Ancestry.com acquired FindAGrave and it remains a free site. Ancestry.com is one of the subscription sites that are available for use at no charge when visiting a Family History Library.

Barbara showed us how to do a “search by location.” By searching an historical collection, she chose Continental Europe and then Germany.

A collection listed with a camera icon in front of the name indicates there is a copy of the record available to be viewed. Those collections listed with a numerical number of records, indicates that the collection is searchable by name. Those collections listed with “browse images” indicate that the microfilm can be viewed on line, but that the records have not been individually indexed and you will have to go through the uploaded microfilm as if using a microfilm reader. With FamilySearch adding millions of records a

week it is good to look back in a few weeks

as the image may be added to the website.

In demonstrating the catalog, Barbara used the word “Jews” and found there were 2,161 items including books, microfilms, etc. An example of place, Barbara used US, CA and LA and for vital records under California births, she found 42 films, however, only six were in the Los Angeles location. If the film wanted is not available in the Los Angeles Family Library you can put in Salt Lake City and order the film on-line. A short term loan of 30 days is \$7.50 but if you want the film on permanent loan in the LA Family History Library its \$18.75. Again, one must register to be able to borrow films.

While foreign records will be in the native language (German, Polish, Dutch etc.) the index is in English which tells you what is



included in the collection.

The JGSLA permanent library is housed at the LA Family History Library, located on the north side of the room. All the books are indexed. To see what is included go to the catalog and type in the name of the book or JGS and what is available will come up.

The FamilySearch “wiki” only has genealogy and one can search on any item. For example, the term “immigration” has 2,926 listings and the word “Ukraine” has 223 items.

There are entire books digitized online and out of copyright. There are 150,000 digitized genealogy and family history publications from selected sites that are listed under “books”. Many family genealogies are listed in books that are out

of copyright and it was recommended to search the books with your family names.

Barbara volunteers most Tuesday afternoons at the LA Family History Library. She strongly encourages that an appointment be made in advance so that she can spend adequate time with you. You may reach Barbara at [barbara@jgscv.org](mailto:barbara@jgscv.org). (More photos below)

# Julius Israel Leburg

May 24, 1876 – June 2, 1916

My Grandfather, Julius Leburg, was born in May of 1876 in Strassbourg, Alsace, France, when it was part of Germany and was called Straßburg, Elsaß-Lothringen, Germany.

As early as 1901 he was married and living in Berlin, Germany.

His only son was born in Berlin in 1903. In 1910 he had his own business with a partner, selling furniture and antiques. When WWI began he was already in his late 30s but he signed up to defend his country.

“He was  
killed on 2  
June 1916 at  
the Battle of  
Verdun . . .”

He was killed on 2 June 1916 at the Battle of Verdun, very close to where he was born. His son was 13 years old when he was killed. On 25 Jan 1942 the Nazis rounded up his widow and her sister and shipped them off to the Riga Concentration Camp in Latvia. In spite of her son’s pleas, she had refused to leave Berlin because she could not believe that the Germans would harm the widow of a War Hero.

There is no specific burial place where my Grandfather’s remains rest, however, his name is mentioned on the very bottom of his parents’ joint tombstone, which is located in the Jewish section of Bergfriedhof Cemetery on Rohrbacher Strasse in Heidelberg, Germany.
